NOTIFICATION for inviting applications for RENEWAL of Merit-cum-Means (MCM) Scholarship and Free studentship for the Session 2020-21.

1. MERIT-CUM-MEANS SCHOLARSHIP:

Online Applications are invited through the ERP for **RENEWAL of Merit-Cum-Means Scholarship and Free Studentship** for the Academic Session 2020-21, from the students of 2nd year onwards of B.Tech.(including Dual Degree 4th year / B Arch. / 5 year Int. M.Sc Course (except Economics Branch) who were awarded MCM Scholarship and FREE studentship in 2019-20. Number of MCM Scholarship awardees shall be restricted to 25% of the students admitted in each year.

SBI Account number with IFSC is mandatory to receive the scholarship.

MERIT CRITERION:

For Renewal: The students' academic performance in the two consecutive semesters of the preceding Session (2019-20) i.e. the GPA (credit based weighted average) as updated after the supplementary examination/summer quarter examination must not be lower than 7.00 without any backlog subject(s) and clearing all prescribed credit requirements during the session 2019-20. Students who have backlog / unregistered in the main subject(s) and could not clear during the same session i.e. in 2019-20 are not eligible for MCM Scholarship and Free studentship for 2020-21.

MEANS CRITERION *(for both Fresh and Renewal)*: The Gross Annual Family Income of a student (parents (both)/ guardian) from all sources in the preceding financial year of 2019-20 (from 1st April 2019 to 31st March, 2020) must not exceed **Rs.600000/-(**Rupees Six Lakh only).

FREE STUDENTSHIP ONLY :

Students who satisfy the specified *Means Criterion* as stated above, but are unable to satisfy the specified *Merit Criterion*, may be granted exemption from payment of Tuition Fees. The number of such tuition-free students shall be restricted to 10% of the students admitted each year.

3. HOW TO APPLY:

- (1) Interested students have to upload the family income document and get it verified by 14th November 2020.
- (2) Students who have already submitted family income documents and are verified need not have to submit again.
- (3) Students have to fill the Online Scholarship Application Form under the Menu Academic > Scholarship (MCM) > Application for MCM Scholarship as per instructions given there on or before 14th November 2020.

N.B.:

- (i) Students need not have to submit hard copy to the academic section.
- (ii) Those students against whom disciplinary have been taken or pending during the preceding year (2019-20) or they have been punished by the competent authority under examination malpractice or involved in violation of code of conduct in Institute / Hall of Residence / Department / Gymkhana are not eligible for award of MCM Scholarship and Free studentship for the year 2020-21.
- (iii) 5th year students of M.Tech. Dual Degree (2016 Batch) can not apply.

Those students whose family income document are already verified for tuition fee waiver for 2020-21 session need not upload again for Scholarship.

All other students (except SC/ST/PD) who want to avail Institute MCM Scholarship must upload their family income documents in the ERP and get it verified by Academic Section for Financial Year 2019-20.

Family income documents to be uploaded for MCM Scholarship:

- Student must upload a family income document as per Annexure I along with an affidavit as per Annexure II.
- The Issuing authority of Family Income Document must be a local District Authority like S.D.O. / B.D. O. / Tahasildar/Mondal Revenue Officer (MRO).
- Alternatively, Form-16 / ITR of Both Parents can also be uploaded as family income document.
- Along with the family income document INCOME AFFIDAVIT as per Annexure II should also be uploaded.

All income documents should be issued for the Financial Year 2019-20.
